# UTILITY BILL PAYMENTS DUE AUGUST 7TH!

## CECIL COUNTY OPEN BURNING RESTRICTION UNTIL AUGUST 31ST

Cecil County has issued a notice that prohibits burning for air quality reasons from June 1st through August 31st.

**During this time, only campfires, that a person might build for "entertainment" and fires for cooking food, are allowed.** Yard waste and trash should be disposed of at the curb, not burned.

and that we are worth exploring. After all, we were the first town in Cecil County to be founded in 1742, and we have a rich history. If you didn't already know, we offer walking tours in our Historic District — check our calendar for dates, or call Town Hall to schedule a private tour!

We've recently updated our Bulk Trash Collection schedule to better accommodate our grass mowing schedule for the Summer. Going forward, bulk items will be collected on the last Tuesday and Wednesday of each month from April to August, and the last Wednesday and Thursday from September to March. As always, please contact Town Hall to schedule a pickup no later than 4:00pm the day before your collection — the first collection day is for South of Route 7, and the second is for North of Route 7. Along with all the changes we've made recently, we are excited about what the future holds, too. **Town Hall** is in the process of migrating to a new accounting/billing software, and upgrading our website. During this transition period, we ask for your patience and understanding as we go through training and implementation. The new software, Edmunds GovTech, was approved by the Commissioners at the June 13th meeting, and will provide us with improved efficiency, better reporting, and comprehensive utility bills. Our upgraded website, which will be complete later this Summer, will also be more comprehensive and user-friendly, as well as more aesthetically pleasing, with an emphasis on our Town's Historic character.

Last, but not least, **designs for a renovated Town Hall and Town Center are still underway**. We appreciate all of the feedback we received at the Public Hearing in February, and are working to incorporate accessibility needs, as well as, an emergency operations center. The proposed commercial kitchen, large meeting space and basement will not only accommodate for these needs, but also community use, and much-needed storage space. Please stay tuned for more updates.

# HOUSEHOLD TRASH & RECYCLABLES INFORMATION

- Major holidays observed by Trash Tech that affect Charlestown service, when holidays are on a Monday, Tuesday or Wednesday, are New Years Day, Memorial Day, Independence Day, Labor Day, and Christmas.
- Please make sure bins are not obstructed for pick up. Keep them to the side of the driveway and away from parked cars and fire hydrants.
- If you have trash or recyclables that are too big to fit in your containers, please call Town Hall to be placed on the bulk trash list. Collection of bulk items is provided during the last week of every month (see page 2 for schedule).
- Please be aware of what's recyclable and what's not. This information can be found on Cecil County's website, under the Residents tab, Solid Waste & Recycling. You will also find here information about **Household Hazardous Waste Days**, which are held by Cecil County Central Landfill in October every year. These events are free for Cecil County residents and are for the disposal of items that aren't collected normally.
- Please contact Town Hall every time household trash and recyclables are not collected as scheduled. Do not contact Trash Tech, as Town Staff keeps record of all missed collections and must notify Trash Tech directly by Thursday at Noon for Friday collection, per our contract. This also applies to damaged or destroyed bins, which will be replaced.

## **IMPORTANT REMINDERS**

- Please do not cover up your water meters. In case of water emergencies, or during quarterly billing, we need to have quick access to your meter to stop leaks or perform necessary maintenance. Covering the meters with flowerbeds or automobiles makes this process much harder for all of us.
- If you have an active Payment Plan with us, payments are due on the 1st of every month to avoid late fees and/or shut-offs. When the 1st falls on a Saturday, payments are due on the next business day.
- For Charlestown residents with P.O. boxes, please make sure to always use your P.O. box as your shipping address — if P.O. boxes aren't accepted, use "ste," "apt," or "unit," instead. Using your physical address may cause your mail and packages to be returned to the sender.
- For Charlestown residents with a North East mailing address, please be aware that you need to call Town Hall in Charlestown for all inquir**ies.** You may live in the North East zip code, but all billing and such is done through Charlestown, not North East. 3
