Happy 245th Flag Day!

On this day in 1777, the first national flag design was approved by the Continental Congress. It consisted of thirteen alternating red and white stripes, and a blue field in the upper left corner with thirteen white stars. The design represented the thirteen colonies that declared independence from Great Britain and their union as the United States of America.

Town Leash Law

As a residential community, the Town encourages all residents to protect our loved ones and neighbors by making sure our dogs are properly restrained, vaccinated, and licensed.

Ordinance #23, which was enacted by the Town Commissioners on May 12, 1970, states:

No person shall permit his dog to be at large or not under restraint in Charlestown. A dog will be deemed to be "at large" when not on the property of its owner and not under the control of a responsible person. A dog is "under restraint" if it is controlled by a leash, or under the control of an owner or other responsible person and obedient to the person's commands, or within a vehicle or within the property limits of its owner or keeper. Any person violating this ordinance shall be guilty of a misdemeanor and upon conviction shall be fined not more than \$25.00 or sentenced to not more than 30 days confinement or both.

Yard Waste is scheduled for collection every 2nd and 4th Monday of every month. Bundles and paper bags or marked bins containing yard waste are collected, but trash bags ARE NOT, as they are not accepted at the county landfill.
