

# **Yard Waste Collection**

Yard Waste is collected by Town maintenance staff on the 2nd and 4th Mondays of each month, or on Tuesday, when Monday is a holiday. Although you do not have to make an appointment with Town Hall, there are some criteria you'll need to follow:

- All yard waste must be placed at the curb by 7am on the day of the pickup, but no more than 48 hours in advance
- Paper bags are strongly encouraged, but bundles are okay, too.
- Trash bags should <u>not</u> be used they are not accepted as yard waste by the landfill.



- If using a trash can, it must have a lid, to keep out water, and be properly marked.
- Bags or containers should **not** weigh more than 50lbs.



## **IMPORTANT REMINDER**

Utility Bills for 3rd Quarter 2022 (July 1—Sept. 30) will be mailed out the first week of October and will reflect the current sewer rate set by Cecil County.

Residents that receive a sewer bill from the County will not be affected by this change as they already pay the higher rate.
