MEETING MINUTES

OLD BUSINESS

Scott Gardens Phase 2 Concept Plan

The developer Lennar and engineer MRA for the Scott Gardens Subdivision presented three alternative proposals for Phase 2. One included a variance request to the minimum lot size requirement, another included a variance for reducing the road width requirement, and the final was by-right development with no variance requests. The Board spoke about the need for wider streets to ensure fire trucks are able to access homes with ease, and the developer presented ideas for traffic-calming, to help prevent speeding. The Board discussed the lot sizes proposed, and wondered what the impacts might be on the forest. Commissioner Capano recommended the developer and engineer meet with the Fire Company to get their input.
