## Façade Improvement Grant Guideline Review

Mr. Lightner provided a brief overview and explained how the scoring and selection was completed in 2020, the last time the Town received these grant funds. He said that once the Town scores the applications, they are sent to Rising Sun, Port Deposit & Perryville for final selection.

The board would like to remove the criteria regarding the target area and change the max grant amount to \$5,000. The board also recommended minor changes to the points system. It was suggested that extra points not be rewarded for certain streets, and suggested an increase for demonstration of need of the improvement.
